
**ORDINANCE REGULATING INSTALLATION OF WATER METERS FOR
SANITARY DISTRICT NO. 4 - TOWN OF BROOKFIELD**

THE COMMISSIONERS OF SANITARY DISTRICT NO. 4 - TOWN OF BROOKFIELD, AND THE TOWN BOARD OF THE TOWN OF BROOKFIELD, WAUKESHA COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

WHEREAS, in order to facilitate the monitoring of water usage, the Commissioners have determined that it is in the best interest of the Sanitary District to install water meters that permit the meters to be read, and usage to be calculated without requiring employees of the Sanitary District to enter residences and business properties to read meters located in the buildings for which water service is provided; and

WHEREAS, the Commissioners have authorized the purchase and installation of an Orion AMR (automatic meter read) unit which allows the meter to be read without entering any residence or business building;

NOW, THEREFORE, be it ordained by the Commissioners of Sanitary District No. 4 – Town of Brookfield as follows:

SECTION 1. Entry of Premises. Upon presentation of credentials, and upon reasonable notice to the property owner, a representative of Sanitary District No. 4 – Town of Brookfield shall have the right to enter, at reasonable times, any residential property or business which has been connected to the water system owned and operated by Sanitary District No. 4 for the purpose of installing and maintaining an automatic water meter reading unit, including the Orion AMR (automatic meter read) unit which has been purchased by the Sanitary District. No person may refuse to permit a representative of the Sanitary District to enter any residential property or building, or refuse to permit a representative of the Sanitary District to install and maintain an automatic water meter reading unit.

SECTION 2. Penalty Provisions. Any person who violates any provision of this Ordinance, shall, upon conviction, forfeit not less than twenty-five dollars (\$25.00) per day nor more than one hundred dollars (\$100.00) per day, together with the cost of prosecution. Each day a violation continues or occurs, shall constitute a separate violation of this Ordinance, and upon conviction, the Court shall impose a forfeiture of not less than the minimum amount of the forfeiture provided for each day the violation continued following issuance of the original citation.

SECTION 3: Jurisdiction. This ordinance may be enforced in any Court of competent jurisdiction, including the Municipal Court of the Town of Brookfield.

SECTION 4: All ordinances or parts of ordinances conflicting with or contravening the provisions of this ordinance are hereby repealed.






