ORDINANCE TO ADOPT THE TOWN OF BROOKFIELD 2022–2042 COMPREHENSIVE PLAN AND LAND USE MAP

The Town Board of the Town of Brookfield, Waukesha County, Wisconsin does ordain as follows:

<u>SECTION 1</u>: Pursuant to Sections 62.23, 61.35, and 60.22(3) of the Wisconsin Statutes, the Town of Brookfield is authorized to prepare and adopt a comprehensive plan as defined in Sections 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes;

<u>SECTION 2</u>: The Town Board, by the enactment of an ordinance, formally adopted its *Comprehensive Development Plan for the Town of Brookfield*–2035 on July 21, 2009.

<u>SECTION 3</u>: The Town Board of the has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by Section 66.1001(4)(a) of the Wisconsin Statutes.

<u>SECTION 4</u>: The Plan Commission of the Town of Brookfield, by a majority vote of the entire Commission as recorded in its official minutes, has recommended adoption of the document entitled "Town of Brookfield 2022–2042 Comprehensive Plan" containing all of the elements specified in Section 66.1001(2) of the Wisconsin Statutes;

<u>SECTION 5</u>: The Town has held at least one public hearing on the document entitled "Town of Brookfield 2022–2042 Comprehensive Plan" and this Ordinance in accordance with Section 66.1001(4)(d) of the Wisconsin Statutes;

SECTION 6: The Town Board of the Town of Brookfield, Wisconsin, does, by enactment of this Ordinance, formally adopts the document entitled "Town of Brookfield 2022-2042 Comprehensive Plan" pursuant to Section 66.1001(4)(c) of the Wisconsin Statutes.

SECTION 8: All ordinances or parts of this Ordinance conflicting or contravening the provisions of this Ordinance are hereby repealed.

SECTION 9: This Ordinance shall take effect upon passage and posting or publication as provided by law.


