TOWN OF BROOKFIELD ARCHITECTURAL REVIEW COMMITTEE MINUTES AUGUST 9, 2023

The regular meeting of the Architectural Review Committee was held in the Erich Gnant Room of the Town Hall, 645 N Janacek Road, Brookfield, WI.

1) CALL TO ORDER.

Chairman Dean Pearson called the meeting to order at 6:00 p.m. with the following people present: Town Planner Bryce Hembrook, Town Supervisors Steve Kohlmann, and John Charlier, Committee members Richard Diercksmeier, and Matt Paris. Alan Lee was absent.

2) MEETING NOTICES.

Planner Hembrook reported that the meeting was noticed in accordance with Open Meeting Law.

3) APPROVAL OF AGENDA.

Motion by Supervisor Kohlmann to approve the agenda. Seconded by Mr. Diercksmeier. *Motion passed unanimously.*

4) APPROVAL OF MINUTES.

Motion by Supervisor Kohlmann to approve the minutes of the July 12, 2023 minutes as amended with the following change; for Item 5, "Chairman Pearson" should be changed to "Mr. Paris" at the beginning of the fourth sentence. Seconded by Supervisor Charlier.

Motion passed unanimously.

5) NEW BUSINESS:

a. Brian Schwartz (Innovative Construction Solutions) is requesting approval for proposed exterior alterations to the east façade of the MLG Capital building, located at 19000 West Bluemound Road. Mr. Schwartz described the changes as updating the east façade by removing existing shiplap, cutting the beams back to the main face of the building, and painting to match the front façade for a cleaner look. Mr. Paris inquired whether it would be obvious that there was once protruding posts (beams). Mr. Schwartz responded that new flat metal plates would be installed to cover, making it a clean finished look. Mr. Paris asked whether lighting would change. Mr. Schwartz responded that the lighting is not planned to change. The concern with lighting on the part of the ARC is glaring to neighboring businesses and Bluemound Road from the fixtures. Mr. Schwartz indicated that the lighting is intended to be decorative, and projecting straight down. Chairman Pearson commented that the lighting on the south façade does glare, and suggested altering that lighting as part of this project.

Motion by Supervisor Charlier to approve proposed exterior alterations to the east façade of the MLG Capital building, located at 19000 West Bluemound Road as presented. Chairman Pearson amended the motion to include addressing the light fixtures and reducing the glare onto Bluemound Road. It was clarified that the fixtures are on the greenhouse section of the building.

Seconded by Supervisor Kohlmann.

The motion was voted on and carried unanimously.

6) COMMUNICATION AND ANNOUCEMENTS.

None.

<u>20225 Watertower Boulevard – Sign Permit</u>

Applicant: Lisa Schroeder (SIGNworks of Wisconsin, Inc)

Location: 20225 Watertower Boulevard. Request: Approval of Permanent Signage

- Requesting to reface the existing monument sign to remove tenant logo and only display the address.
- Background will be black with white acrylic push thru letters.
- Double-sided monument sign.
- Sign area is approximately 23.56 square feet each side.
- Proposed sign meets all other sign code requirements.

Recommended Action: Approve the sign as presented.

Little Steps – Sign Permit

Applicant: Kwan Kim (SM Deluxe Sign) representing Little Steps

Location: 19601 West Bluemound Road. Request: Approval of Permanent Signage

- Proposing to add a channel letter wall sign near the entrance of the tenant space.
- The channel letters will be internally illuminated and will be predominantly white with some black background.
- Proposed sign area = 32.62 square feet
- Tenant building frontage is 90'.
 - o Allowable sign area allowed = 72 square feet.
- The Code states that there should be a "maximum of two wall-mounted signs per building, subject to the area limits described above, on buildings principally used as offices". The other tenants with signage on the building include a bank and law office. Although these businesses serve as offices, they provide services to customers and are customer oriented businesses rather than business intended solely for

office workers. Due to this, staff believes that allowing the wall mounted signage above the tenant space is appropriate in this situation and that this requirement does not apply in this situation.

Proposed sign meets all other sign code requirements.

Recommended Action: Approve the sign as presented.

Cabinets MKE – Sign Permit

Applicant: Frances Hoysradt (LED Supply & Signs) representing Cabinets MKE

Location: 18895 W Bluemound Rd, Suite 4 Request: Approval of Permanent Signage

- Requesting to add two permanent signs on the building.
- Proposing to add one multi-tenant sign panel to the existing multi-tenant freestanding sign.
 - o Proposed background is white with orange and blue lettering and logo.
 - o Sign area is approximately 7.49 square feet and is internally illuminated.
- Proposing to add a 49.5 square foot front lit channel letter sign.
 - o Letter and logo colors are orange and blue.
 - o Tenant frontage = 21'
 - Allowable square footage = 16.8 square feet
 - Does not meet code requirements.
 - Building frontage = 140'
 - Total allowable square footage for building = 112 square feet
 - The total sign area of all wall signage on the building is currently 96.7 square feet. The proposed sign will increase that total to 146.2 square feet.
 - Does not meet code requirements.
- One thing to note is that the proposed colors of the sign are different than the other existing signage on the building, which generally consist of green, white, and black backgrounds/lettering. Staff did not find a master sign plan in the property records.
- For comparison purposes, the ARC approved Azara wall signage for up to 23.5 square feet and 21.5 square feet for Fava Tea Company. Both tenant frontages are between 21-24'.
- Proposed sign meets all other sign code requirements.

Recommended Action: Per the discretion of the Committee.

Novus Home Mortgage – Sign Permit

Applicant: Jeffrey Hojnacki (Ascend Design Inc) representing Shake Shack

Location: 20225 Watertower Boulevard Request: Approval of Permanent Signage

- Requesting to add a 67.5 square foot wall mounted sign with internally illuminated channel letters.
- The sign will have a raceway that matches the brick and there will be white and green letters.
- The proposed sign will replace the existing OnCourse Learning sign.
- Tenant building frontage is approximately 90'.
 - o Allowable sign area allowed = 72 square feet
- Proposed sign meets all other sign code requirements.

Recommended Action: Approve the sign as presented.



 - o Allowable sign area allowed = 23.67'

Recommended Action: Approve the signs as presented.




