<ul> <li>SITE SURVEY OR SKETCH DETAILING EROSION CONTROL PROVISIONS</li> <li>LOCATIONS OF EXISTING AND PROPOSED DWELLINGS WITH RESPECT TO THE PROPERTY LINES AND THE LIMITS OF THE LAND DISTURBANCE ACTIVITIES</li> <li>DIRECTION OF SLOPE BEFORE AND AFTER LAND DISTURBANCE, AND THE SIZE OF THE UN-SLOPE DRAINAGE AREA</li> <li>LOCATIONS OF ALL TEMPORARY BEST MANAGEMENT PROACTICES TO CONTROL EROSION FROM THE SITE</li> <li>INDICATE EXISTING GROUND COVER ON SITE (I.E. CONDITIONS OF APPROVAL						
<ul> <li>EROSION AND SEDIMENT CONTROL MEASURES SHALL BE INSTALLED PRIOR TO ANY LAND DISTURBING ACTIVITIES</li> <li>INSPECT THE EROSION AND SEDIMENT CONTROL PROACTICES AFTER EACH RAIN OR ½ INCHES OR MORE AT LEAST ONCE EACH WEEK AND MAKE NEEDED REPAIRS.</li> <li>NO SILT FENCE WILL BE REQUIRED FOR THIS SITE, BUT IF RUNOFF BECOMES A PROBLEM, IT WILL BE REQUIRED</li> <li>MONITOR AND MAINTAIN A SILT FENCE ON SITE UNTIL THE SITE IS STABILIZED</li> <li>INSTALL A GRAVEL ACCESS OF 3" STONE TO A DEPTH OF 6", SEVEN (7) FEET WIDE AND AT LEAST FIFTY (50) FEET LONG. ALL GRAVEL AND SOIL PILES MUST BE KEPT AT LEAST FIFTEEN (15) FEET FROM THE ROAD AREA. ANY SEDIMENT THAT LEAVES THE SITE AND ENTERS THE ROADWAY MUST BE CLEANED UP BY THE END OF EACH WORK DAY. ALL PRACTICES MUST BE MAINTAINED UNTIL THE SITE IS STABILIZED WITH SEED AND MULCH OR SOD.</li> </ul>
