 Class "B" Fermented Malt Beverage Retailer's License for Acme Group, Inc. d/b/a Prime Cigar Co. at 18900 W Bluemound Rd, Ste 148.

Attorney Van Kleunen provided an overview of recent events regarding licensure for Prime Cigar Co. to explain how the entity had previously held a "combination license" and that when the Town Board denied renewal of the Class B liquor license for 2024-2025, approval of the Class B beer license was inadvertently overlooked.

The Board discussed a desire for the Clerk to eventually coordinate a process for routine inspections of licensed premises.

Motion by Schatzman to issue a Class B Malt Beverage license to Acme Group, Inc. d/b/a Prime Cigar Co. at 18900 W Bluemound Rd., Ste 148; seconded by Stanelle.

Motion prevailed by a voice vote (5-0).
